COLUSA COUNTY GENERAL PLAN UPDATE AMENDING THE LAND USE MAP

In 1989, the County adopted its current comprehensive General Plan. Since that time, the General Plan and especially the Land Use Maps, have guided communities, as well as individuals in making personal and financial decisions.

The General Plan Update will fine-tune the Land Use Maps to meet projected residential, commercial, industrial, and recreational land needs throughout the County. Groups and individuals may submit Land Use Map Request Forms. However, the focus will be on comprehensive community planning—consistent with General Plan goals and principles developed during the visioning process—rather than individual development projects.

The General Plan consultant team and County staff will evaluate all Land Use Map Change Request Forms according to factors stated on the form. County staff will respond in writing to all groups or persons who submit a Land Use Map Change Request Form, stating whether staff recommends the request be approved.

Requests that staff recommends for approval will be shown on the draft General Plan Land Use Maps presented for review at community meetings, and by Planning Commission and Board of Supervisors at public hearings. Persons requesting Land Use Map changes that are not recommended by staff for approval (and not shown on the draft Land Use Maps) may make their case at the public hearings (anticipated to be held in August 2010 and in 2011).

Community meetings and public hearings will be advertised via the General Plan Update website, mailing list and media advertising. All persons who submitted Land Use Map Change Request Forms will receive a notice of the public hearings.

HOW TO SUBMIT A LAND USE MAP CHANGE REQUEST COLUSA COUNTY GENERAL PLAN UPDATE

- Land Use Map change requests using the County's Land Use Map Change Request Form, accompanied by a \$160 fee payable to Colusa County, may be submitted to the Colusa County Planning Department, 220 20th Street, Colusa, CA 95932.
- 2. The County's consultants and County staff will evaluate each 'Land Use Map Change Request Form' based on factors provided on the Form. The County will respond in writing to all groups or persons who submit a Land Use Map Change Request Form, stating whether staff recommends the request be approved. Requests that staff recommends for approval will be shown on the preferred General Plan Land Use Map that will be included in the Draft General Plan and analyzed in the Environmental Impact Report prepared for the General Plan Update.
- 3. The Board of Supervisors will hold public hearings to consider the draft General Plan Land Use Maps. All persons who submitted Land Use Map Change Request Forms will receive a notice of the public hearings. Persons requesting Land Use Map changes that are not recommended by staff for approval (and not shown on the draft Land Use Maps) may make their case at the public hearings to consider the preferred Land Use Map (anticipated to be held in August 2010 and in 2011).
- 4. Persons dissatisfied with the General Plan Land Use Maps ultimately adopted by the County (anticipated in 2011) may file a standard General Plan amendment application during the next annual amendment cycle.
